In case any Central Public Information Officer (CPIO) or First Appellate Authority (FAA) is transferred to any other Division replacing any other CPIO/ FAA or a new officer joins in the place of the existing CPIO/FAA, he or she would automatically be the CPIO/ FAA of the corresponding items of work handled by the earlier CPIO/ FAA. In case any CPIO/FAA proceeds on leave, tour, training etc. the officer who is given the additional/ temporary charge of his/ her items of work, would automatically be the CPIO/ FAA for those items of work, irrespective of his/ her designation/ post.
